Sub clauses a,b,c of the article 3.1.2. of the Constitution of the Sri Lanka Energy Managers Association

[Refer (5) of the application form]

1.1.2 Institutional Members - Any company, corporation, partnership of association of good standing and operate in Sri Lanka may be an Institutional Member if they satisfy the following requirements:

- (a) Entities whose operations utilize or consume energy.
- (b) entities in the business of generating, transmitting, transforming, storing or marketing of energy or energy consuming devices or machinery.
- (c) Entities which provide services in the field of Energy Conservation and Management.

3.3.2 Institutional Members
